## **VIII. Constitution and Bylaws**

*Bre and Delegates*

The Executive Board has brought three proposed changes to this conference, which were submitted more than two weeks prior. The Parliamentarian will serve as the author by reading all of the changes and then will open the floor for debate. A 2/3 majority is required for these proposed changes to pass. The first change is focused on the secretary-treasurer position on the board and the other one focuses on the 2-year budget change that the General Assembly voted for and passed at the last conference.

### **Motion to Add a Treasurer Position to the Executive Board of AASG:**

#### **West Valley/Eagle River**

**Bre:** We decided as an Executive Board at the summer business meeting that it would be best to split the secretary-treasurer position.

**Ariel:** The changes that were just read off by Bre are ones that would come with adding a treasurer position to the Executive Board.

**Palmer Point of Information:** Will the new treasurer position be filled at this AASG conference? If not, when?

**Bre:** This change would come into effect at the next fall conference. The treasurer would be appointed at the same time as the secretary.

**Mat-Su Career & Tech Point of Information:** The numbering on these constitution and bylaw changes go in order as 7, 9, 8, 9. Can you fix that?

**Ariel:** Our apologies, that's a mistake that does not need to be voted on. We will fix it.

**Kodiak Point of Information:** In the bylaws, it states that the treasurer would give a report at every General Assembly. Does that really mean before every single General Assembly in a conference?

**Ariel:** That means that the treasurer will give a report once per conference just like the other officers.

**Mat-Su Career & Tech Point of Information:** Does the current secretary-treasurer feel like her job is too much?

**Celeste:** The secretary-treasurer position is a bit overwhelming. Taking and editing minutes takes a considerable amount of time to do, especially when GA minutes can add up to 60+ pages which need to be submitted within a two-week window. As for the other side of my position, I did not receive any formal training to manage budgets and honestly had no background experience with budgets when coming onto the board. I believe that splitting the position up and electing a treasurer to the Executive Board with experience would be the best decision for this organization.

#### **Motion Passes**

**Motion to Add Article 5, Subsection 3, and Subsection 0 to the Bylaws, Which is to Evaluate the Executive Director at Every Summer Business Meeting:  
Colony/Lumen Christi**

**Sitka Point of Information:** Are we discussing an amendment to the change just passed?

**Ariel:** We just passed the change to add a treasurer position which had several changes attached to it regarding the new position, but right now we are just discussing a bylaw change that only has one particular change affiliate with it.

**Lake and Peninsula Point of Information:** What would evaluating the Executive Director mean and what would happen if you decided that they were failing at their duties?

**Ariel:** The Executive Board's evaluation of the Executive Director would have no effect on their actual employment because they are contracted with ASAA. The benefit of this change would be that the board can sit down together and look at what's not working, how they can improve, or what they can keep doing that they're doing well. If something was severe, the board could then present the matter to ASAA to discuss different options for contracting.

**Motion to Make the Junior SBEED Representative a Voting Member on the AASG Executive Board:

**Lake and Peninsula Point of Information:** Is there a reason that this position wasn't a voting position before?

**Kobe:** When the Junior SBEED Representative comes onto the AASG Executive Board, there is no special training for them, just as there isn't for nearly every other member on the board. For this reason, they should have their own vote.

**Mat-Su Career & Tech Point of Privilege:** Can you please zoom in on the screen so that we can see the text in the back?

**Homer Point of Information:** How many members on the AASG Executive Board currently vote?

**Bre:** All members vote except for the Parliamentarian, Secretary-Treasurer, and President (in the exception of a tie).

**Ariel:** There are 12 voting members, unless there's a tie, in which there would be 13.

**Sitka Point of Information:** Does the current SBEED Representative believe that the junior representative would be qualified to vote?

**Kobe:** That is a good question. When you look at the other positions, as soon as they are elected, they are given the right to vote. When the junior representative is selected, three candidates are considered by the State Board of Education and Early Development and they pick one. At this point, they are not qualified yet. There is not a training period for that position to be on the AASG Executive Board, which is the same as other positions, so there isn't a reason that they should be considered less qualified than anyone else.

**Palmer:** We are in support of this bylaw change because currently, the senior and junior SBEED representatives share a vote, so if they don't agree on something, the vote is abstained. It would be fairer if they both were able to vote as individuals.

**New Lockers for Sand Point School**  
**Submitted by Sand Point School Student Council**  
**Sand Point School**

**1. Be it resolved by the Alaska Association of Student Governments;**

2. **Whereas**, the lockers in the hallways of Sand Point School haven't been replaced in the 30 plus years of our school's history;

3. **Whereas**, the lockers in the Sand Point School hallways, on multiple occasions, injured students with the sharp latch that is meant to secure the door;

4. **Whereas**, the hallway lockers have been in poor condition for many years and are in need of maintenance throughout the year;

5. **Whereas**, some lockers don't close completely, open easily, or some don't open at all;

6. **Whereas**, there are approximately 20 broken lockers in the secondary hallway alone;

7. **Whereas**, Sand Point School enrollment has increased by 10 students in the 2014-2015 school year and our current lockers are not reliable enough for the increase of enrollment;

8. **Whereas**, our current lockers are not spacious enough for many student's belongings and school supplies when there are many vacant lockers that space could be used more efficiently with larger lockers;

9. **Whereas**, in the article, "How Are Lockers an Advantage In Schools?" it was said that "The fact that lockers contain the valuables that students need to succeed like books and homework, students want to know that their belongings are safe within their lockers and that they're not likely to get stolen or ruined; if they know this then the lockers will get the correct usage and students will respect each other's lockers in order to preserve their own."\*1;

10; **Whereas**, our current lockers lack security for students belongings.

**Therefore be it resolved by the Alaska Association of Student Governments that the Sand Point School replaces our old lockers in the hallways of the Sand Point School with new, better, and more spacious lockers in the hallways of the Sand Point School.**

**Action Statement-** This resolution, if approved by the General Assembly of the Alaska Association of Student Governments, is to be presented to the Aleutians East Borough School Board, the Aleutians East Borough School District Superintendent, and the Aleutians East Borough School District Business Manager by the Sand Point School Student Council.

**Sitka:** The cost associated with this resolution is negligible. Remember that we are not here to debate on the cost associated with resolutions; we are here just to debate on the merit of resolutions. It's obvious that the lockers pose a danger to the student body.

**Eagle River Point of Information:** Where will the funding for this resolution come from?

**Author:** The funding would come from our school district. We have talked to our Bureau about this too, and they said that if this resolution was passed, it will go to the business manager next.

**Mat-Su Career & Tech:** As a student, I would expect to have a safe lockers that would not injure me and would keep my things secure.

**Tri-Valley Point of Information:** How many students that go to your school have lockers?

**Author:** There are about 107 students who use lockers, and with the increase in enrollment, we've had to have our one maintenance man repair at least 13 lockers.

**Lake and Peninsula:** I am in support of this resolution in regards to the funding coming from the school board's district because it's their responsibility to ensure that there is safe environment for the students, and if valuables are being stolen, that is clearly not safe.

**Hutchison:** One of our main priorities here should be keeping students at school safe, so passing this resolution shouldn't even be a question.

**Palmer:** I am in support of this resolution because our school has not had new lockers for 70 years and we've seen that they are dangerous.

**Mat-Su Career & Tech Point of Information:** Do you have the space for new lockers?

**Author:** We have a lot of space; we'll build as many lockers as the space allows us to do so. The new lockers would provide three times more space.

6. **Whereas**, P.E. is a required credit for graduation at Tri-Valley High School;
7. **Whereas**, Weights and Conditioning is an offered class at Tri-Valley School;
8. **Whereas**, the Weights and Conditioning class uses the Tri-Valley weight room,
9. **Whereas**, it is highly dangerous to use the old outdated equipment in the weight room;
10. **Whereas**, all of the equipment has been here longer than any of us have been in High School, and a vast majority of it is broken and almost inoperable;
11. **Whereas**, cardio equipment, such as the treadmill, is broken and will randomly shut off, making it unreliable and unsafe for any student or faculty to use;
12. **Whereas**, people have tried to repair some of the equipment with athletic tape or duct tape,
13. **Whereas**, the universal weight machine is missing pins, and bolts and screws are being used instead,
14. **Whereas**, bolts and screws aren't made for the universal machine, so it will sometimes cause the machine to malfunction, which makes using it unsafe,
15. **Whereas**, students avoid using the weight room because it is dangerous;
16. **Whereas**, The overall state of the weight room is hazardous,

**Therefore, be it resolved by the GA of AASG, that Tri-Valley School updates the equipment in the weight room to make it safe for students, staff, and community members to use.**

**Wasilla Point of Information:** Will Tri-Valley replace all of its equipment or just some of it?

**Author:** We want to replace all of it.

**Lake and Peninsula Point of Information:** Is there an estimate cost?

**Author:** To replace all of the equipment, it is estimated to cost \$50,000. This amount could be spread out so that we could gradually raise the money and could also come from constructional material. Also, the school district allows for some of its money to spent on school improvement.

**North Pole Point of Information:** Do you have any alternative physical fitness classes?

**Author:** The only physical education credits Tri-Valley offers are weights and conditioning, which is not offered every year. Students can waive part of the class through sports, but usually end up having to take the class.

**Ben Eielson Point of Information:** Is it worth replacing all of the equipment based off of the number of people that use it?

**Author:** Yes, because every student that passes through Tri-Valley will have to use the weight room because they will need to take the weights and conditioning class. Community members use the weight room as well.

**Author:** Not that I know of. When we talked about this to school administration, they had said that they would take out the broken equipment, but the majority of the equipment is already broken.

**Be it resolved by the general assembly of the Alaskan Association of Student Governments.**

1. **Whereas**, teens need an average of 9 ¼ hours of sleep each night for optimal performance<sup>1</sup>.
2. **Whereas**, Melatonin is responsible for regulating everyone's sleep/wake cycles.<sup>6</sup>
3. **Whereas**, the average teenager produces melatonin at 11 p.m., and keeps pumping until after sunrise.<sup>2</sup>
4. **Whereas**, melatonin is produced more in the dark<sup>3</sup>; affecting students who drive to school in the mornings.
5. **Whereas**, not getting enough sleep (sleep deprivation) can result in emotional and behavioral problems; such as, irritability, depression, stress, poor impulse control, and violence<sup>4</sup>.
6. **Whereas**, sleep deprivation hinders students' work ethic, listening skills, and performance<sup>5</sup>.
7. **Whereas**, people who work are on the roads, heading to their jobs, around the same time students who drive head to school.
8. **Whereas**, students will no longer interfere with peoples work schedule, and people who work will no longer interfere with students' school schedule.
9. **Whereas**, fewer busses would be on the streets at once, resulting in students and workers being late fewer times due to busses.
10. **Whereas**, a study in 2002 estimated that for each hour of sleep lost, the odds of an adolescents being obese rose by 80 percent.<sup>7</sup>  
**(Circadian rhythms are physical, mental, and behavioral changes that follow a roughly 24-hour cycle<sup>9</sup>, and can influence sleep-wake cycles, hormone release, body temperature, and other important bodily functions<sup>10</sup>.)**
11. **Whereas**, as a teenage body goes through puberty, its circadian rhythm essentially shifts three hours backwards.<sup>8</sup>  
**(Not only is it difficult to fall asleep at around 9 or 10 to get the proper amount of sleep needed, its nearly biologically impossible)**
12. **Whereas**, dopamine is a neurotransmitter whose main functions are regulating mood, sleep, and memory.<sup>11</sup>
13. **Whereas**, dopamine is directly tied to wakefulness, so the best way to get the most out of it is to get plenty of sleep.

**Therefore**, be it resolved by the General Assembly of the Alaska Association of Student Government is in favor of moving High School start and end times 45 minutes later in the day for the Mat Su Borough.

**Action Statement**, this resolution if passed by the General Assembly of the Alaska Association of Student Government, will be sent the Mat Su Borough School Board.

**Bethel Point of Information:** Does the author have contact with other schools in its bureau?

**Author:** Yes.

**Lake and Peninsula Point of Information:** What did the other schools in your region say in response to this resolution?

**Author:** There were a few that were for it and there were a few that were against it.

**Barrow Point of Information:** Is there a specific reason for shifting the start time to 45 minutes later?

**Author:** There is no particular reason.

**Mt. Edgecumbe Point of Information:** What time does school start and end at Mat-Su Career and Technical high?

**Author:** We start at 7:58 AM and end at 1:46 PM. Other schools in our region, such as Colony, starts at 7:45 AM and ends at 3:15 PM.

**Kodiak:** Were other schools asked their opinion on this resolution before it was written?

**Author:** Yes.

**Chugiak Point of Information:** By other schools, do you mean other high schools or elementary schools as well?

**Author:** This resolution pertains only to high schools.

**Lake and Peninsula Point of Information:** Have you considered how this change might adversely affect students? For example, it might force some students to change their schedules in regards to after school activities or jobs.

**Author:** If this resolution does pass, then we would have to adjust the after school activities times.

**Bethel Point of Information:** Do you have the exact number of how many opposed this resolution and how many approved of it?

**Author:** No.

**Hutchison:** How is 45 minutes enough time to give the desired affect or outcome you're looking for?

**Author:** This resolution is not a solid solution to the problem, but we anticipate that it will help.

**Mt. Edgecumbe Point of Information:** Would this change only benefit students and not the community?

**Author:** It may not directly benefit the community, but students getting an adequate amount of sleep is important.

**Homer Point of Information:** Do any other schools in the valley have zero hour classes?

**Author:** No, but we do have after school classes.

**Palmer:** There are zero hour classes in the district. They are dependent on student availability to take those classes. Wasilla high school offers a zero hour weight class, for example.

**Tri-Valley Point of Information:** It was previously stated that this resolution was only for high schools. How would this affect elementary and middle school schedules?

**Author:** Because both high school and middle school students ride the busses in the morning, we would have to get another set of busses to take them separately.

**Sand Point:** I agree with the 45 minute shift because I have a friend who goes to Mat-Su Career & Technical high school. It takes her 45 minutes just to get to school when it takes me like 5 minutes. I think those 45 minutes would make a difference because the students wouldn't have to wake up at 4:00 AM.

**Wasilla Point of Information:** When would this be impended into the school's schedule?

**Author:** That is still in discussion.

**Juneau Douglas:** I find that the studies are irrelevant, because for more than half of year that we go to school, we all have to drive to school in the dark.

**Lathrop:** People have been saying that it wouldn't give them more time to sleep, which is not the point. The point is that the time shift would allow for a better chemical balance in the students' brains.

**Ben Eielson:** Due to the lack of statistics gathered, it's not our place to vote on this resolution because not all of us are in their school district.

**Advanced Placement® Exam Credit**

**Be it resolved by the Mat-Su Career and Technical High School Student Government;**

- 1. Whereas,** the Matanuska Susitna Borough School District currently requires students to receive a minimum of 22.0 credits to graduate\*2;
- 2. Whereas,** Advanced Placement® courses are designed at a level beyond that of standard high school courses;
- 3. Whereas,** 90% of colleges and universities in the US accept Advanced Placement® credits from high school as a substitute for introductory college and university courses\*1;
- 4. Whereas,** the Advanced Placement® exam is an accurate reflection of knowledge from said Advanced Placement® course;
- 5. Whereas,** if a student can pass the Advanced Placement® exam they must have the knowledge of said Advanced Placement® course's curriculum;
- 6. Whereas,** students can take an Advanced Placement® exam without having taken the said course in a high school setting;
- 7. Whereas,** students should be encouraged to take Advanced Placement® courses;
- 8. Whereas,** many Advanced Placement® courses are not available through the Matanuska Susitna School District or approved third parties;
- 9. Whereas,** approved third parties can be expensive\*3;
- 10. Whereas,** free third party courses are available over the web, along with easily accessible textbooks and other resources for Advanced Placement® courses\*4;
- 11. Whereas,** unapproved third parties and resources can adequately prepare students for the Advanced Placement® exam;

**Therefore, be it resolved by the Mat-Su Career and Technical High School Student Government that students who pass the Advanced Placement® exam with a score of a 4 or 5 receive credit and a “P” (Passing) for the said Advanced Placement® course.**

Action Statement- This resolution, if passed in General Assembly at the Alaska Association of Student Governments, is to be sent to all members of the Matanuska Susitna Borough School Board (attached contacts), and presented at the next Matanuska Susitna Borough School Board meeting.

**Sitka:** We agree with this resolution. It is excellent because it will provide credit for the work that exceptional students do, inside or outside of school. However, the only thing I would like to see changed about this resolution is to see it applied to the entire state.

**Lake and Peninsula:** We are also in support of this resolution because in the school district we come from, these courses aren't even available, so students within the district aren't as prepared for college as other students in the state may be. **Mat-Su Career & Tech Point of Information:** Is there any knowledge on whether or not other school districts have the same policy on awarding AP credit for students that pass the exam but do not take the class?

**Kodiak Point of Information:** For all seniors, if they needed another math credit and thought they could pass, their course won't be available until July. How would that apply?

**Author:** This would be a positive change, however because students won't take the AP exams until mid-June, students won't receive their scores until after they graduate. This would mainly apply to sophomores and juniors.

**Eagle River:** Is it fair that students will be able to show up the day of test and pass compared to another student who has to take the class and work for their grade for the entire course?

**Hydaburg Point of Privilege:** We can't see the resolution because the screen is black.

**Hutchison Point of Privilege:** Because there is construction going on, can people talk a little louder?

**Ariel:** Yes, our school is under construction at the moment, so would Executive Board members and delegates please speak louder and enunciate their words?

**Palmer:** We're in support of this amendment because we feel that each school is individualized with an honors program. The state board of education would be encouraged to buy \$80 tests. Public education shouldn't force students to take tests that cost them money.

### **Amendment Passes with Noted Opposition**

**Mat-Su Career & Tech:** We are also in favor of the amendment because this resolution will give people who don't have time in high school the option not to take the test and still pass and get credit for it, dependent upon whether or not they know the material.

### **Motion to Amend Therefore Statement to State that in Order to Pass the AP Exam, the Student Must Earn a Score of 3 or 5: Wasilla/Juneau Douglas**

**Sitka:** It's also important to know that if you get a score of a 3 on AP exam, you have at least a 60%, and in high school, that's still passing.

**Mat-Su Career & Tech:** If they get a 3 on the AP exam, it's kind of like a C letter grade. It would be better if they were required to get a 4 or a 5, whereas 3 would constitute as "almost" knowing the information.

**Hydaburg:** There is a popular saying: "C's get degrees."

**Homer:** Not all schools in Alaska recognize 60% as a passing grade.

**Bethel:** If a college is willing to accept the credit, then why shouldn't high schools be willing to accept that grade too?

**Eagle River:** The point of the AP exam is not just to pass; it is to provide more rigorous courses. If a student just takes it and passes, they're not really learning or showing that they know the material well.

**Lathrop:** I'm not sure about any one else, but in my school, a 3 out of 5 is a 60%, which is a D letter grade, and is considered to be a passing grade.

**Mat-Su Career & Tech:** Colleges that students apply to will see the AP exam scores first, and if C is what the student got, they may not see the A or B that the student got in their normal high school classes. It might not appeal to colleges.

**Sitka:** It's obvious that having a 60% or a C doesn't sound rigorous, but it's important to know that AP exams are not easy to pass. I think it's impossible for someone to walk in without having taken the class and pass with a soaring grade. Colleges won't know these things. Even a 60 % shows that you at least know the material and probably had to study.

**Palmer Point of Information:** How would this affect a student's GPA? If we get a P, it could become a 4. For example, we could get a C on the AP exam but still be given full high school credit. It seems inadequate.

**Author:** The idea is that the student would have to get a passing grade. It would not have any bearing whatsoever on their high school GPA, which is dependent on their work in their high school classes.

**Delta:** In our school district, all AP scores are weighted, so it's not a big deal in our school.

**Thunder Mountain Point of Information:** I have a question for the region representatives: What is accepted as a passing grade in your districts?

**Region 1: A "D" is accepted as passing**

**Region 2: 65% is a "D" and anything below is an "F"**

## Resolution #6

### Alaska Association of Student Governments

#### Ensuring the Long-Term Stability of the Eagle River High School Fine Arts Program

*Resolution Composed by the ERHS SG Executive Board*

*September-October 2014*

**Be it resolved by the Eagle River High School Student Government** that the Alaska State Legislature allocate all necessary funding for the creation of a fully functional auditorium for Eagle River High School by the year 2025,

- 1) **Whereas**, all fully functioning high schools in the Anchorage School District possess auditory facilities with the sole exception of Eagle River High School, which is deprived of these facilities,
- 2) **Whereas**, the deprivation of these facilities leads to a deficit in Eagle River High School's students' fine arts capacities and greater understanding of the world around them,
- 3) **Whereas**, Eagle River High School currently only possesses a rudimentary stage that has less square footage than a professional equivalent,
- 4) **Whereas**, the acoustics of the aforementioned facility are subpar,
- 5) **Whereas**, students have a fundamental right to learning and education,
- 6) **Whereas**, a fully balanced curriculum fields a fine arts component<sup>1</sup>, and an auditorium would catalyze the fulfillment of this instrumental element of a balanced education,
- 7) **Whereas**, the Center for Arts Education asserts that fine arts are linked to an amelioration of graduation rates<sup>2</sup>,
- 8) **Whereas**, fine arts notably improve motor skills, inventiveness, cultural awareness, language development, visual learning, and academic performances of students,
- 9) **Whereas**, the contemporary sculptor Richard MacDonald maintains that, "Fine art comes from the soul. If you have virtuosity and facility, you can take and create something of significance."
- 10) **Whereas**, MacDonald's words lend credence to the idea that fine arts are a noteworthy installment in contemporary society and the advancement of civilization,
- 11) **Whereas**, the nineteenth century artist Gustave Courbet once remarked, "Fine art is knowledge made visible."
- 12) **Whereas**, under Courbet's line of reasoning, fine arts constitute a critical way in which students can express their knowledge and understanding of the material they obtain in an academic environment,

- 13) **Whereas**, it is clear that the addition of an auditorium to the Eagle River High School campus would greatly aid Eagle River High School in actualizing the full fine arts potential of its students, as well as aid Eagle River High School in increasing student aptitude in other academic realms,
- 14) **Whereas**, the precedents set by the construction of an ERHS auditorium would serve as powerful fodder for other Alaskan schools to spur further expansion of existing fine arts facilities or catalyze construction of new fine arts facilities if they [Alaskan schools] do not currently possess any [facilities],
- 15) **Whereas**, the National State Arts Agency total projected appropriations in the 2014 fiscal year is \$307.2 million, and the Agency's total projected appropriations in the 2015 fiscal year is \$367.4 million<sup>3</sup>,
- 16) **Whereas**, from the 2014 to 2015 fiscal years, the Arts Agency's per capita investment rose \$0.19, and the Legislature was able to successfully appropriate 75.8% of the State Art Agency Revenue in the 2014 fiscal year<sup>4</sup>,
- 17) **Whereas**, the cost of a new Eagle River High School auditorium would be approximately eight million dollars, a fully feasible quantity given the Arts Agency's existing appropriations levels,

**Action Statement: This resolution, if passed by the Eagle River High School Student Government, will proceed onwards to the ASD Student Advisory Board. If passed at the Student Advisory Board, the resolution will proceed onwards to the Fall 2014 Conference of the Alaska Association of Student Governments. ## **General Assembly at Ease from 9:13am to 9:14am**

**Ariel:** A resolution is able to be debated without a therefore statement, for those of you who did not know.

**Sitka Point of Information:** Is there reasoning behind Eagle River sending this resolution to state legislature if passed and not to the school board representative of Eagle River?

**Author:** What is most important in this resolution is the source of funding. If we send it straight to the state legislature, they would be aware of the project sooner.

**Homer Point of Information:** Has there been a space allotted for this auditorium?

**Author:** Yes. Back in 2005 when the school was built, we had a lot of land. There is an entire field belonging to the school that has undergone no construction.

**Lake and Peninsula Point of Information:** Who decided that \$8 million is a negligible cost?

**Author:** Our estimate comes from the Anchorage school district sanction. They got their funding through the State of Arts Agency. It has about \$300 million. \$8 million is 2% of that budget.

**Thunder Point of Information:** Will this be for community use as well?

**Author:** Yes. The school will lease the building out to private 3<sup>rd</sup> party advisors.

**Hutchison Point of Information:** Since Eagle River doesn't have an auditorium, what were they using before?

**Author:** Right now, our school only has a small stage in Commons, which is half the size of this gym. Because it's located in the Commons, the sound echoes, making it difficult for performers.

**Barrow Point of Information:** What does Eagle River's fine arts program consist of?

**Author:** Currently, there are only 2 choirs that use it. Everything else has been eliminated.

**Ben Eielson Point of Information:** How many students are in the fine arts program?

**Author:** I do not have an exact count, but the fine arts program applies to every student in one way or another. We have a very tight-knit school.

**Lake and Peninsula Point of Information:** If there have already been cuts made to the fine arts program, how would funding for this auditorium take place?

**Author:** Allocation.

**Eagle River:** There are avid participants in our school's fine arts program. It's really difficult to perform in the Commons. We all work together to host a performance. Students would build the new area themselves, with support from teachers. It would take about a month or a month and a half. It would take a long time because the students would need to learn everything and that is a lot of work. It's overbearing. The theater department funding was just cut. The theater teacher is now teaching in the elementary school. She was an important part of our school and is no longer there. We are currently sharing with the Chugiak theater department, so their advisor has been coming in to teach us. It's a good experience, but I would prefer that our school had our own theater department advisor. Our department could benefit if we could get the auditorium. I have friends who are trying to get a show next semester. We are trying to get production together but it's difficult.

**Hydaburg:** Would the auditorium be set up with microphones and lights? Have those things been taken into account regarding the budget?

**Author:** Yes, they are included in the budget. Eagle River would follow other auditorium models.

**Thunder Mountain Point of Information:** Would you collaborate with other groups who use the makeshift stage?

**Author:** The auditorium would serve as a meeting ground for other clubs too.

**Lake and Peninsula:** I do not feel that an auditorium is necessary for the appreciation of the fine arts program. Everything that the other speaker said was inspiring, but I feel that appreciation can be shown in other ways.

**Hutchison Point of Information:** Do you have a community fine arts building where the community can come and go to perform?

**Author:** Yes, but it is about 10 miles away. Also, there are school spirit issues with not having our own theater.

## Resolution #5

### Resolution to Institute Restorative Justice in Alaska

Alaska Association of Student Governments

Written by: Josh Hartman and Cassidy Jeffers

Submitted by: Mat-Su Career & Technical High School and Palmer High School Student Governments

#### Be it resolved by the general assembly of the Alaskan Association of Student Governments:

1. **Whereas**, 90% of voters polled strongly support reducing prison terms for low-risk nonviolent offenders if they are well behaved or complete programs.<sup>4</sup>
2. **Whereas**, the Anchorage Wellness Court is the only court in the state of Alaska that focuses on rehabilitating offenders (drug and alcohol crimes specifically).<sup>5</sup>
3. **Whereas**, Alaska has the highest rate of recidivism of felons in the United States
4. **Whereas**, a system of restorative justice would focus on restoring the victim, rehabilitating the offender, and repairing the community.
5. **Whereas**, the current system of retribution focuses on using strict punishments to deter people from offending.
6. **Whereas**, a rehabilitative system would help decrease the recidivism rate and therefore the number of people in prisons.
7. **Whereas**, a restorative system of justice should be implemented to relieve the current justice system and to improve the Alaskan community as a whole.
8. **Whereas**, people with mental illness will be diagnosed by professionals and if possible given treatment options to help them be productive members of the community.
9. **Whereas**, in Alaska it costs \$136 per day per inmate or \$49,800 per year.<sup>6</sup>

10. **Whereas**, it cost states more than \$10 billion dollars for the additional time served by the offenders released in 2009 compared to those released in 1990, a 19 year difference.<sup>7</sup>
11. **Whereas**, 1,934 offenders with at least one felony were sampled. 66% were re-incarcerated for a new offence or probation or parole violation and 59% were arrested at least once for a new offense and 29% of those sampled had data indicating a mental health problem. Of those released, 26% reoffended within six months, 38% reoffended within a year, 52% reoffended within two years and 59% reoffended within three years.<sup>8</sup>
12. **Whereas**, the Alaska State Legislature has the ability to create new rehabilitative courts.

**Therefore: be it resolved by the Alaska Association of Student Governments that punishing justice should be supplemented with a system of rehabilitation for the offender and restoration for the affected party. This will be done by implementing an alternative court system that offenders can go through to get rehabilitation, counseling, or any other needs required to become contributing members of the community.**

**Action Statement: This resolution, if approved by the General Assembly of AASG, will be sent to Alaska State Senator Hollis French to be brought up the Alaska State Legislators to be passed there.**

**Sitka:** It's no secret that the Alaska penal system is pathetic at the moment. We value drug abuse and substance abuse by putting those offenders in jail for much longer than they should be. This is a great resolution, but there are a few things I would like to amend, however, it was made well enough to where if it was sent to the Alaska legislature, they would be able to comprehend it. I fully support this resolution because the state of Alaska has the highest use of drugs in the country.

**Lake and Peninsula Point of Information:** It seems that the author is suggesting an entirely new court system to go into place along with the old one. Would there be a way to combine the two to give prisoners treatment?

**Author:** We were not suggesting that a new system be created, just new facilities to be created to help the prisoners. For example, we would like more psychologists, etc.

**Thunder Mountain Point of Information:** We need clarification on whereas statement 9. Would the number raise or lower if we instituted a program rehabilitate prisoners?

**Author:** The cost may increase, but only on a short-term level. The current cost per year is \$49,800 for one inmate. When you look at the total cost of a full year, it's much greater than the cost of being rehabilitated for a month. Essentially, it would cost less.

**Bethel Point of Information:** For the inmates going through a probation period, would this affect their probation?

**Author:** Most likely, yes. The program would be individualized. The period would be shorter.

**Lake and Peninsula Point of Information:** Whereas statement 3 needs a source.

**Author:** That statement has the same source as statement 11.

**Barrow Point of Information:** Whereas statement 11 needs clarification. There are several different statistics.

**Author:** These are a number of different statistics.

**Lathrop Point of Information:** I am curious if a program like this has been effective in other states.

**Author:** I did not see a lot of programs like this in other states when researching. Other countries use similar systems and also offer university classes and physical therapy, which has proven to help inmates.

**Hutchison Point of Information:** Has there been statistics proving that rehab for inmates or felons work at the standard?

**Author:** For first time offenders, it has proven to work, but not necessarily for murderers. The less serious of an offense, the more likely it is that the rehab will help the offenders.

**Unalaska:** Our local police station supports this. Other police stations have been talking about this idea throughout the state because they'd rather see an increase in helping these people and the community rather than spending money.

**Lathrop Point of Information:** Does the current system work now?

**Author:** The current system does not do a good of job of preventing the prisoner from committing crimes again. So many that enter the system re-offend.

**Hydaburg Point of Information:** In your research, have you looked at the cost of these programs?

**Author:** I did not find the cost per prisoner. It would be extrapolated to be less than the amount to keep the current system.

**Bethel Point of Information:** If one of the offenders show that they are not able to be rehabilitated, what would happen?

**Author:** In that case, they might be mentally ill, and would receive treatment. If the rehab didn't work, then they'd go through the normal court system.

**Homer Point of Information:** Is this program for felons or inmates who have committed smaller offenses?  
**Author:** The number of felons and low-risk one-time offenders is not mutually exclusive. If someone brings marijuana to school, that counts as a class C felony. This would aim mostly at low-risk, one-time offenders, but could help virtually anyone in the system that wants help.

**North Pole:** I agree with the community service part but disagree with whereas statement 1. If they plead guilty, they deserve to suffer the consequences. If we do not apply punishment, then the offenders will believe that they can continue their behavior.

**Bethel Point of Order:** I would like to remind all delegates to try not to use charged language when making a statement.

**Juneau Douglas:** We support this resolution. The cost would not be expensive. Also, we discussed having a trial where we could do an experiment to get actual proof of the rehabilitation system working. If it worked, then it could be applied to the whole state.

**Mt. Edgecumbe:** I support this resolution strongly. We shouldn't be concerning ourselves with finances because this is a great opportunity for the offenders to get back on their feet. Everyone deserves a second chance.

**Colony:** Colony high school supports this resolution. It's important that first-time offenders get the help that they need. We need to use rehab to help the general wellbeing of those sent to jail for addiction.

**Establishing a Dual Enrollment System for ASD High Schools**  
Drafted by ERHS Class of 2015

**Be it resolved by the Alaska Association of Student Governments** to encourage the Anchorage School District School Board to develop a plan to create a dual enrollment system for all ASD high schools, through which students enrolled in ASD high schools would have the option of taking college classes in lieu of high school classes, through the University of Alaska Anchorage.

1. **Whereas**, students could integrate taking afternoon classes at UAA alongside their morning classes at their Anchorage School District high school,
2. **Whereas**, the program would function modeled after Mat-Su's Middle College dual enrollment program, where high school students change campuses to be instructed alongside college students,
3. **Whereas**, classes would be free to students who already qualify for the Alaska Performance Scholarship,
4. **Whereas**, students would have the advantage of receiving college credit while still in high school allowing the to excel to their own potential,
5. **Whereas**, students would be more acclimated to college courses before becoming a full time undergraduate student in the future,
6. **Whereas**, students who currently face scheduling conflicts at their Anchorage School District high school would have a wider range of options to take their desired courses with UAA,
7. **Whereas**, students who do not have a specific course offered at their Anchorage School District high school would be able to broaden their selection of courses at UAA,
9. **Whereas**, taking a college class can help students find their area of interest before the added pressure of choosing a major,
10. **Whereas**, students who participated in the dual enrollment for at least a year, increased the likelihood of completing a degree in less than average time by 41%,
11. **Whereas**, students would gain college experience while living in a financially, and socially familiar atmosphere,
12. **Whereas**, students would be exposed to a college class schedule of a class meeting fewer times a week, syllabuses, and office hours,
13. **Whereas**, teachers who taught higher level classes could focus their attention to more remedial classes in order to provide more attention to students who require more personal assistance,
14. **Whereas**, students would develop time management skills, to be easily transferred later in education to a full college schedule.

**Action Statement:** This resolution, if passed by the Eagle River High School Student Government, will proceed onwards to the ASD Student Advisory Board, and if passed there, the Fall 2014 Conference of the Alaska Association of Student Governments. **Lake and Peninsula Point of Information:** I need further clarification on the statement about APS classes. Would the classes be free or would it take money from scholarship funds?

**Author:** After speaking with the dean of UAA, he said they'd be willing to change their standards to qualify for the APS, and that students can use the credit while still in high school. Students would have the ability to take the majority of their classes.

**Palmer Point of Information:** Regarding whereas statement 3, would students have to pay to take those classes if they did not already qualify for the APS and needed the classes?

**Author:** The school would receive funding from the district for students to take those courses while in high school, but at the moment, I cannot say that we've received funding.

**Lake and Peninsula Point of Information:** Is there a reason that this system has not already been implemented?

**Author:** In the past, our school has examined dual enrollment at an intermediate level, but until this point and time, no other student government has pursued this.

4. **Whereas**, the Alaska Performance Scholarship math and science category requires four credits of mathematics, and the social studies category requires three credits.
5. **Whereas**, forty-two states require a higher graduation requirement for mathematics;
6. **Whereas**, forty-seven districts in Alaska already require more than two credits of math to receive a diploma in that district;
7. **Whereas**, this change would keep Alaska's districts more consistent;

**Whereas**, Tobacco use remains the leading cause of preventable death in Alaska, causing nearly 600 deaths each year; and

Whereas, Approximately one-fifth of all deaths in Alaska are caused by tobacco use; and

**Whereas**, Tobacco use causes more deaths each year in Alaska than suicide, motor vehicle crashes, chronic liver disease and cirrhosis, homicide, and HIV/AIDS combined; and

**Whereas**, In 2013, 36% of high school students statewide had ever tried cigarette smoking; and

**Whereas**, In 2013, 8% of Fairbanks North Star Borough high school students who responded to the Youth Risk Behavior Survey reported smoking cigarettes; and

**Whereas**, In 2013, 9% of high school students in Alaska used smokeless tobacco and 21% of Alaska Native students used smokeless tobacco; and

**Whereas**, Secondhand smoke contains more than 7,000 chemicals, including at least 69 of which are known to cause cancer, including formaldehyde, benzene, vinyl chloride, arsenic, ammonia and hydrogen cyanide, and people who are exposed to secondhand smoke are inhaling many of the same cancer-causing substances and poisons as smokers; and

**Whereas**, The 2010 U.S. Surgeon General’s Report, “How Tobacco Smoke Causes Disease,” determined that even occasional exposure to secondhand smoke is harmful; and

**Whereas**, a completely tobacco-free environment is a strategy proven to help prevent youth from ever smoking and demonstrate to youth that tobacco use is not the norm; and

**Whereas**, the current policy for Fairbanks North Star Borough School District is not considered Gold Standard because it is missing important elements that ensure all students, staff and visitors are protected from the harms of secondhand smoke;

**Whereas**, currently visitors can smoke on campus, and adhering to the Gold Star Standard would prevent visitors from doing so;

***Be it resolved by the Alaska Association of Student Governments***, the current Fairbanks North Star Borough School District policy should be revised to meet a Gold Standard Tobacco Free School to improve the health and well being of our students, staff and community.
