Palmer: Yes, Rural and Urban areas should be equal and get the availability of internet.

Eielson: Fully support this resolution, but it would be very expensive to afford internet all across Alaska.

Valdez: Point if information: Was wondering what the reasoning was of your school board for deciding to limiting access this much? Was there a problem?

Palmer: It was actually not ever brought up to the school board, the decision was made by CIS, and was discussed at school board but there was never a vote on it.

Wasilla: The funding isn't any issue, the reason why Palmer is having this problem because teachers don't use the basic websites as students use. This is punishing the entire student body, so they wanted to use the money elsewhere.

Valdez: Point of information: There were excuses with the internet, but as Wasilla said, comparing to a sixteen thousand person school district, 20 people isn't that much of a percentage at all to have the rest of the students suffer for not being able to have internet access.
