Motion to bring resolution #1 to the floor Sitka/ North Pole Motion Passes

South Anchorage High School Resolution #1: Restoring Anchorage Arts Money Cuts Region 1: Region one did not support this resolution with noted support Region 2: region two supported the intent of this resolution Region 3: region three supported this resolution but needed more information Region 4: region four supported with noted opposition Region 5: We are all for resolution number one Region 6: supported with noted opposition Region 7: region seven supports this resolution

West Valley: statement one, says the office of administration

Motion to amend the \$110,000 thousand decrease in funding to \$111,000 decreasing in funding West Valley/Service Motion Passes

Chugiak: I love the intent of this resolution, how ever I believe that the money was taken out of the account for great reasons. It goes to the homeless. I have a feeling that the money goes to people that need it more than the arts, they have other opportunities to get money.

West Valley: I would like to direct this question to the author, why the money was cut, and where do they get the money?

Author: all the bills got cut. I understand that the economy is in crisis. At least with my statistics that a hundred and ten thousand dollars is a lot. We had bought two new zambonies, and that was more than a hundred and ten thousand dollars and the fact that there was money to be spent, and that they spent it on something needing less is what I am trying to get my point at.

Barrow: I have a question directed to the author. Was the same percentage of money taken from other organizations? **Author**: I do know that there were cuts, but I am not sure if they were the same amount of money.

Resolution passes with noted opposition:

Alaska Association of Student Governments Resolution: #1 (PASSED) Restoring Anchorage Arts Money Cuts Submitted by: Savannah Woolston

- 1. Whereas, in 2009, the Arts Commission was receiving \$261,000 in funding. In 2010, it was cut to \$150,000. This is a \$111,000 decrease in funding in one year. The funding provides money for 73 arts organizations around Anchorage (7);
- 2. Whereas, theatre, the imagined and enacted world of human beings, is one of the primary ways children learn about life -- about actions and consequences, about customs and beliefs, about others and themselves (3);
- **3.** Whereas, there is a direct relationship between improved SAT scores and the length of time spent studying the arts. Those children who studied the arts for four or more years scored 60 points higher on verbal and 41 points higher on math portions of the SAT than students with no experience in the arts (6);
- 4. Whereas, involvement in the arts makes students two times more likely to win an award for academic achievement, four times more likely to participate in a math or science fair, nearly twice as likely to read for pleasure, three times more likely to win an award for school attendance, over three times more likely to be elected to a class office in school, over four times more likely to engage in community service (2);
- 5. Whereas, since the No Child Left Behind Act, there has been a national focus on closing the "achievement gap" between students of varying abilities, socioeconomic status, and other factors that may affect a student's academic success. The arts address this issue by catering to different styles of learning, and engaging students who might not otherwise take interest in academics (3);
- 6. Whereas, a 1992 Florida Dept of Education study of at-risk students, "The Role of the Fine and Performing Arts in High School Dropout Prevention," found that 75% said participation in the arts influenced their decision to graduate from high school (4);
- 7. Whereas, The Alaska Theater of Youth provides services to 170 artists or

performers, 200 paying students, 35 teachers, 22 scholarship actors/students, 300 volunteers, and an estimated 18,300 audience members every year (5);

- 8. Whereas, "As the national financial crisis continues into its second year, youth arts organizations like Alaska Theatre of Youth must continue to operate without government, foundation and corporate support that it had relied on for the past 26 years of operation. Such support is typical for non-profit arts organizations to draw upon to pay for operating costs, hiring experienced teachers, training, the creation of costumes-sets-props, etc." (5);
- **9.** Whereas, community theatre programs give back to the community by providing transportation to productions for low income students, scholarships for training programs, and free participation in productions (5);
- 10. Therefore, be it resolved by the Alaska Association of Student Governments, that the cuts to money for arts programs in the Municipality of Anchorage be restored because arts organizations are indispensable programs that produce meaningful results to youth and the community, and they are not receiving the funding they currently need to be sustainable.

Author: this would just act as a waver; they would be able to take this class out. The student who passes this test would still have to take a social studies class.

Author: with this resolution I am using it as a voice, so that we can have a test out. If the government of Alaska approved this, SBEED will be able to pay for it. Mt. Edgecumbe: on the first whereas statement it said that there were tons of conflicts and I was wondering what these conflicts were?

Meeting at Ease 8:48 are Meeting called back to order at 8:49 am

Author: one of the worst things that can ever happen to you is that you have to take social studies class on one state such as Alaska Studies and move out of state and your credit does not apply at your transferred school. Then you would have to go to the counselor and plan out a schedule. If you don't want to take it then it's really hard to work out. The student goes into this course knowing that it does not apply to out of state credits and knows they are wasting their time. Of course the test out option would be able to change this. The rigidity of the schedule is what I am trying to get at. **Chugiak**: at Chugiak our teacher only teaches AK history, and if we get rid of this class than he will loose his job. And the last thing we need is to have people lose their jobs.

South: he is not talking about getting rid of the class he is talking about people test out of the class. The class can still be there, it's just that there will be an option of having the class being tested out.

Chugiak: the purpose of this class is to reduce racism in Alaska. We should make this class mandatory so that they can help enlighten racism in our state.

Dimond: if the last comment is true, than we would need to have a class for all races that was unnecessary information.

Eagle River: I would like the board and the assembly to recognize that the student's voice to the state department of association is important, I recognize that there is a flaw in the resolution; some seniors are victimized for the graduation. I wanted to introduce an option for a test out.

Wasilla: I would like to direct this question to the SBEED rep. how do you think that the board would feel about the resolution?

Tim: I do not think that the board would support this.

Nikiski: I would just like to say that our AK teacher is not that great, and a test out option would be great. Also we are able to test out of every class.

Motion to call the Question Lathrop/ Hutchison High School Division of the House Motion Passes with noted opposition

Resolution Fails with Noted Opposition

Alaska Association of Student Governments Resolution: #3 (FAILED) Test Outs for Alaska Studies Course Submitted by: Eagle River High School Tanner Lyon

- 1. Whereas, the current statewide requirement for Alaskan students to take "Alaska Studies" has sparked several conflicts;
- 2. Whereas, Alaska Studies credits are non-transferable across state borders;
- **3.** Whereas, students who fulfilled similar requirements in another state are not exempted from Alaska Studies classes;
- **4.** Whereas, the State of Alaska hosts a high concentration of military personnel and families who continually rotate in and out of the state;
- 5. Whereas, the total population of the State of Alaska is 670, 053 people.
- 6. Whereas, the total military population of the State of Alaska is about 17,111 people.*
- 7. Whereas, any student that moves into the State of Alaska is subject to the requirement to take Alaska Studies to graduate.
- **8.** Whereas, the requirement for Alaska students to take Alaska Studies unnecessarily restricts student choice;
- **9.** Whereas, schedule flexibility is severely hindered by the Alaska Studies requirement;

- **10. Whereas**, it is questionable as to whether or not the current curriculum is effectively implemented;
- **11. Whereas,** taking Alaska Studies has the potential to lower an individual's GPA if that individual is taking Advanced Placement classes that add weight to their GPA, due to the lack of an AP option for Alaska Studies.
- 12. Therefore, be it resolved by the Alaska Association of Student Governments, to request the Alaska State Department of Education produce and provide a test out alternative to high school seniors for the completion of the Alaska Studies requirement.

Action Statement: This resolution, if approved by the GA of AASG, will be brought before the Alaska Department of Education to be finalized and ratified on a statewide level.

Chugiak: I have a problem with the citations. The citations with one and two are not backed up with numerical evidence. These are optional sites, not like U.S.S Borough. I do not think these are great citations.

Motion to amend to strike line seven Chugiak/Nikiski **Monroe:** I would like to say that I am against striking that because this is deemed more constitutional because it is a statement that's saying they are restricting it more and more.

Monroe: the only reason that line number seven is in there because since 1978, they have been using this and it's been restricted since the first time. **Division of the House**

Motion to striking line seven has passed with noted opposition

Meeting at ease 2:37 pm Meeting called back to order at 2:50pm

Grace Christain: as a mission statement of UA schools and I quote "UAA is committed to serving the higher education needs of the state, its communities, and its diverse peoples." Both the requirements "Higher education" and "diverse peoples" are requirements for admission under the current system: however it is made obvious that higher education is primary criterion. The phrase" diverse peoples" ought not to be criterion for admission but the inexorable truth: select the most capable collegiate hopefuls of UA schools, regardless of color or race, and enroll them in UA schools. You would still be met with fantastically diverse class, but a class untied on the plane of collegiate capability and potential. This criterion is a violation of the civil equity of members of an unprejudiced society and ought to be removed at the earliest feasible opportunity, in order to eliminate racial consideration from the UA schools admission process.

Wasilla: as a minority school, I believe that racial diversity is important in high school because it teaches you that you can succeed in collage because minorities do exist.

Hutch: on any application it is an option to check race boxes. Races cannot be a factor at all; by doing that it does truly make the society better.

Nikiski: We are not a color blind state; we have tons of minority groups. I find "whereas number 3" incorrect based to a great amount of research.

Service: If you take the ethnicity part out you might as well take the boy/ girl part out as well.

Mt. Edgecumbe: Being Alaska Native, I am offended by "whereas statements one and two." We actually called UAA; race is not a factor for acceptances, with that said I would like to call the question.

Motion to call the question Edgecumbe/ Wasilla Motion on calling the question has failed

Monroe: I called UAA and UAF also, and they do take people from out of state without the race box filled in.

Juneau: I support your intent, but I think it needs more proof.

North Pole: we at North Pole think the intent is correct, this resolution is appropriate, because I feel that a person should be noted by his accomplishments and not his race.

Grace Christain: in response to the comment of "whereas number three," our country is founded on equal opportunity, with my suggestion that collage education is an opportunity.

Motion to strike line two South/ Bethel Motion Passes

Chugiak: we brought this up in our region meeting, how it will actually affect the UAA admissions. It's their board and their decisions to affect their school's acceptance rate by race.

Motion to call the Question Called Tri Valley/ Eagle River Motion Passes with noted opposition

Resolution Fails with noted opposition

Alaska Association of Student Governments Resolution: #4 (FAILED) Eliminating Race in the Admission Consideration at UA schools Submitted by: Monroe Catholic High School Sierra Minder

- 1. Whereas, the students most prepared for college should have the best opportunity of getting in;
- 2. Whereas, race is no longer an accurate way to judge someone's educational opportunities*2;
- 3. Whereas, race no longer implies economic background*2;
- 4. Whereas, this leads to reverse discrimination*1;
- 5. Whereas, it would help lead to a truly color-blind society;
- 6. Whereas, the impact would result in an enhancement in the education system;
- 7. Whereas, it would encourage and promote competition;
- 8. Whereas, it is condescending to minorities to say they need affirmative action to succeed*1;

- 9. Whereas, it demeans true minority achievement; i.e. success is labeled as result of affirmative action rather than hard work and ability*1;
- 10. Whereas, this would not require any special funding;
- **11. Whereas,** it would be practical to enforce by simply not allowing colleges to ask the ethnic background of perspective prospective students;
- 12. Whereas, campuses can still be diverse;
- **13. Whereas,** much progress has been made since 1978 and race does not need to be a factor at all anymore;
- 14. Therefore, be it resolved by the Alaska Association of Student Governments that University of Alaska eliminate racial consideration in the admission process.

Alaska Association of Student Governments Resolution: #8 (PASSED) Increasing Safety on Whitshed Road Submitted by: Cordova Jr/Sr High School Keegan Crowley, Laura Kacsh, Angie Kelly, Christina Morrisett, and Alvin Velasco

- **1.Whereas**, the portion of Whitshed Road from the Copper River Highway to the new park, "Field of Dreams" is used heavily by pedestrian and bicycle traffic where there are no shoulders on the road, a cliff on one side, and a drainage ditch on the other, thereby inhibiting safe passage;
- **2. Whereas**, there are 130 children in Cordova Little League between the ages of five and fifteen that use the "Field of Dreams" for baseball and softball practices and games (Reggiani);
- **3. Whereas**, the Cordova Parks and Recreation Department have made available a new multi-use soccer, volleyball, kickball, football field that can also be used for festivals and community events adjacent to the "Field of Dreams," thereby significantly increasing use of the property (Herschleb);
- **4. Whereas**, there are blind corners before and after the "Field of Dreams" on Whitshed Road in which drivers cannot see pedestrians until within short distances of them;
- **5. Whereas**, within 1/8 of a mile of the ball field there is a Public Works building, a working gravel pit, and a baler facility, requiring the use of heavy industrial vehicles that pass the ball field throughout the day;
- **6. Whereas**, there is increased summer traffic on Whitshed Road throughout the summer going to the Eccles Creek boatyard;
- **7.Whereas**, the new road development at the end of Hartney Bay Road will further increase traffic including residential traffic and construction crews;
- **8. Whereas**, many drivers tend to drive 1 to 5 miles per hour over the posted speed limit, thereby increasing the average miles per hour to 40 miles per hour;
- **9. Whereas**, although posted speeds are not necessarily the same as travel speeds or impact speeds, the data gathered by the U.S. Department of Transportation clearly suggest a strong relationship between higher vehicle speed and the greater severity of resulting personal injury due to pedestrian/vehicle accidents ("Literature Review on Vehicle Travel Speeds and Pedestrian Injuries");
- 10. Whereas, it was concluded that 3.7% of pedestrian/vehicle accidents are fatal at 25 miles per hour vehicle speed, but 12.5% of pedestrian/vehicle accidents are fatal at 35 miles per hour vehicle speed ("Literature Review on Vehicle Travel Speeds and Pedestrian Injuries");
- **11.** Whereas, reducing the speed limit by 10 miles per hour would increase commute time in that half mile section by approximately 20 seconds, a negligible

increase;

- 12. Whereas, the Cordova Parent Teacher Organization received a grant through the Safe Routes to School program from which \$185,000 will be allocated to designing a bike path to the "Field of Dreams," providing funding for a part of the project;
- 13. Therefore be it resolved by the Alaska Association of Student Governments that the City of Cordova reduce the speed limit on Whitshed Road from the Copper River Highway to the "Field of Dreams" to 25 mph and install a bike/pedestrian pathway along this same stretch of road as soon as possible to avoid potential injuries and death among the members of our community.

Action Statement: If ratified by the GA of AASG, this resolution is to be presented to the Cordova City Council and the Cordova School Board by a delegation from Cordova Student Council, and the Vice-President of the Executive Board will present the ratified resolution via mail to the same bodies.

- 1. Whereas, the implementation of a four-day (optional five-day) school week at Kodiak High School will exceed the required number of instructional hours set forth in AS 14.03.030, by allotting 6.75 hours of instructional time per school day;
- **2.** Whereas, if approved, classes may be scheduled from 8:00 A.M. to 3:50 P.M. Monday through Thursday to meet the required instructional hours;
- **3.** Whereas, if approved, formal classes will not be scheduled on Fridays, enabling students and teachers to travel off-island for extracurricular activities without missing official instructional time;
- 4. Whereas, a total of 867 student absences, equal to approximately 3,900 total hours of lost instructional time, is attributed to student activities and traveling on 19 Fridays during the first, second, and third quarters of the 2009/2010 school year (Willis);
- **5.** Whereas, a four-day school week at Kodiak High School will increase direct instructional time as a result of improved student and teacher attendance;

- 6. Whereas, personal appointments, professional development, special events, and parent conferences can take place on Fridays, without interruption of instructional time;
- 7. Whereas, high school faculty will be required to work 16 Fridays per year and support staff will be required on Fridays, so that all staff will work the same number of hours per year as during the traditional five-day school week;
- 8. Whereas, students will have access to school services on Fridays, including tutoring, counseling, library access, teachers' office hours, and free and reduced-price lunch for eligible students;
- **9.** Whereas, Fridays will provide students with increased opportunities for work, volunteer, and internship experiences, as well as club meetings and outdoor learning activities such as field trips;
- **10. Whereas,** an extra day of non-instructional time will enable students to complete schoolwork and pursue extracurricular activities with reduced stress and a greater balance amongst school, work, and personal commitments;
- **11. Whereas,** a four-day school week will further enable the construction of the new Kodiak High School in select areas without interrupting instructional time;
- **12. Whereas,** the Administrators of Kodiak High School recognize the high school's transition to a four-day school week as an effective means to increase instructional time;
- **13. Whereas,** the transition to a four-day school week was suggested by students, and later voted on by the student body of Kodiak High School as the top initiative for school improvement over other issues in December 2009, as part of Student Council's RSVP (Raising Student Voice and Participation) program;
- 14. Whereas, a study of schools which implemented a four-day school week in Idaho, Oregon, and Colorado reports an increase in both student and teacher attendance in nearly all school cases; test scores in these same schools either increased or remained constant (Beesley);

- 7. Whereas, 100,000 children carry guns to school, nationwide, per month, in the interest of self-defense;
- 8. Whereas, those who experience bullying suffer from low self-esteem, poor confidence, and are less likely to pursue post-secondary education;

- **10. Whereas,** the consequences concerning bullying as stated in school policies are not outlined to greatest clarity;

Alaska Association of Student Governments Resolution: #13 (PASSED) Classroom Expansion Funding Submitted by: Mt. Edgecumbe High School Candace Schaack and Zoe Merculieff

- 1. Whereas, Mt. Edgecumbe High School (MEHS) is a state run public boarding school in Sitka that serves 400 students from rural communities all around Alaska;
- 2. Whereas, the school has played an important role in preparing generations of rural and Native Alaska Leaders;
- **3.** Whereas, currently there are four classrooms located on upper campus two of which positioned in a building known as 'Kuspuk Hall' and two more in the dining hall facility;
- 4. Whereas, this semester there are 166 students taking classes on upper campus;
- 5. Whereas, it as an approximate seven minute (440 yards/ 1320 feet) walk from lower campus to upper campus;
- 6. Whereas, MEHS passing periods are only 5 minutes;
- 7. Whereas, students with classes on upper campus do not have time to use the bathroom during passing periods;
- 8. Whereas, a student may have to go back and forth multiple times within a school day in rain and snow just to get to their classes;
- 9. Whereas, Sitka's average rainfall each year is 86 inches*1;
- **10. Whereas,** students already have to walk to upper campus to get to the cafeteria for lunch;
- **11. Whereas,** if funding were granted to MEHS, students with classes located on upper campus would be able to stay on lower campus, eliminating walking long distances in inclement weather;
- 12. Whereas, the new wing will connect the gymnasium and activity center;
- **13. Whereas,** in addition to a new set of classrooms, there will also be a commons area established for students;
- **14. Whereas,** "the goal is to bring all the classes together so that it makes a greater collective learning environment"*2;
- **15. Whereas,** in Girls Main Dorm and Boys Main Dorm currently there are up to 6 students living in one room;
- **16. Whereas,** MEHS currently has to get a Child Care Licensing Waiver to have 5-6 students sleeping in one room*3;

- **17. Whereas,** if the classrooms located in Kuspuk Hall & above the dining hall were moved to lower campus then they would be renovated into dormitory housing;
- 18. Whereas, the expansion project is estimated to cost a total of \$9.3 million *4;
- **19.** Whereas, at the Fall Conference 2009 at West High School, the GA passed a resolution supporting funding for the renovation of Kodiak H.S.
- **20. Whereas,** any of MEHS school's construction projects must be funded with direct appropriations by the legislators and governor *4;
- **21. Whereas,** if the budget was approved, the expansion project would begin as early as summer 2012 *4;
- 22. Therefore, be it resolved, that the Alaska Association of Student Governments strongly supports the appropriation of capital funds to meet the long-standing needs of Mt. Edgecumbe High School.

Action Statement: This resolution, if approved by the GA of AASG, is to be sent to the Alaska State Legislature, the Governor, and the Department of Education.
