This task force was created with the passing of Senate Bill 221, the Alaska performance scholarship. Its purpose is to combat Alaska's low graduation rate and the high rate of remediation for Alaskans who go to college. On this task force are the President of Alaska Senate Senator Gary Stevens; Speaker of the Alaska House of Representatives Representative Chanault; Presidents of UAA, UAF ; the Commissioner of Education and Early Development; and may other dedicated Alaskans. We have met in

Anchorage for a meeting, in urban environments, in Fairbanks for a look at the college setting, and in Nome, Alaska for a look a more rural community. We have made significant progress in the last couple of months and plan to present to the legislature in late March early April. Resolution #2 (PASSED)

Academic Activity Enhancement through Participation

Submitted by: Bethany Hladick

Be it resolved by the Alaska Association of Student Governments;

1. Whereas, high school students that attend Unalaska City School are limited to 20 days for school sponsored travel, which includes academic and athletic travel;

- 2. Whereas,** Unalaska City School District requires students to maintain a 2.5 grade point average in order to participate in school sponsored travel;
- 3. Whereas,** academic activities such as Student Government, Oceanic Science Bowls, Music Competitions, Skills USA, Business Clubs of America, and Academic Decathlons positively enrich a student's academic performance;
- 4. Whereas,** a travel policy should not be in place to limit a student's academic performance;
- 5. Whereas,** your co-curricular experiences are valuable to your personal and professional development;²

In-School Suspension
Submitted by Tessa Bay**

Be it resolved by the Alaska Association of Student Governments;

- 1. Whereas**, the average length of a suspension from school in the Anchorage School District for a basic offense (i.e truancy, obscenity, disruptive behavior, etc) is 5 days;
- 2. Whereas**, students who are suspended are mostly students with a history of inappropriate behavior, poor grades, or other indiscretions;
- 3. Whereas**, students who are suspended are not allowed to attend school, therefore leaving them without a meaningful use of their time;
- 4. Whereas**, students who are suspended from school have no direct in-school access to their teachers or assignments, which is detrimental to their education;
- 5. Whereas**, students who are suspended are often the ones in most need of a good education; out-of-school-suspension is not conducive to that goal;
- 6. Whereas**, students who are deemed guilty of indiscretions can be punished just as well with in-school suspension, during which they are placed in a room during the school day, not allowed to talk to or see any other students, but are supervised and have ample time to complete their class assignments;
- 7. Whereas**, assigning these students out-of-school suspension under the supervision of unknown parental figures can increase the chances of further violations of district rules; however, keeping these students in school and under the firm guidance of district officials will prevent continuing such behavior;

8. Whereas, the Anchorage School Board’s mission statement is as follows: “To educate all students for success in life.”;

9. Whereas, suspending a student from school no matter what their infraction - therefore making any academic achievements difficult - is not advantageous to the student’s education or success later in life;

10. Therefore, be it resolved by the Alaska Association of Student Governments that students sentenced to 14 days or less of out-of-school suspension be subject to in-school suspension instead, providing that the student’s offense does not suggest that there will be harm to the student body by keeping them in school.

4. Whereas, Palmer High School's graduation is scheduled (by the major Mat-Su Valley high school principals) for 1:00 PM on Wednesday, May 18; this is during normal work hours for many employed parents and loved ones;

Suicide Prevention in Alaska High Schools

Be it resolved by the Alaska Association of Student Governments;

- 1. Whereas,** Alaska leads the nation in suicide rates; ¹
- 2. Whereas,** teens tend to talk to their peers first, rather than adults when considering suicide;
- 3. Whereas,** suicidal teens feel uncomfortable talking to their parents about suicide and 86% of the parents of teens that committed suicide were unaware that their child was suicidal; ¹

4. Whereas, the majority of suicides in Alaska have been committed by people of the ages 15 to 22; ¹

5. Whereas, 90% of teens who die from suicide have a mental health problem, usually depression, substance abuse, or both; ²

6. Whereas, nationwide more teens die of suicide than of AIDS, cancer, birth defects, stroke, pneumonia, influenza, and chronic lung disease combined; ²

7. Whereas, the signs of potential suicide can be subtle and hard to notice without proper training;

8. Whereas, after a suicide crisis, friends and family are at an increased risk of developing post-traumatic stress disorder, which may lead to a cluster of suicides;

9. Whereas, Alaska provides a number of opportunities for suicide prevention trainings or events;

10. Whereas, schools usually provide grief counseling immediately following a suicide, but this tends to eventually be discontinued or dissipate;

11. Therefore, be it resolved by the Alaska Association of Student Governments that all high schools should provide suicide prevention training or awareness events.
