Sophie, Corey

Sophie Clark: I've been working quite a bit on suicide prevention. At the beginning of the school year I traveled to all the schools on my island and did the "Chain of Life" activity. I think it was pretty successful, and overall I presented to 3 schools other than Klawock. Also, Craig has expressed interest in having me come to present after I return from AASG. I'll be communicating more with their administration afterwards. Also, I got a request a couple weeks before the conference to present the Kognito training to my school's staff members. I contacted Kate Burkhart and got the login info and provided the training on Oct 19. It was a bit short notice, but I'm really excited that my administration is noticing all the work that has been done for suicide prevention and have opened their eyes to the resources that are available to them. I didn't hear any complaints from the staff, and many of them noted that it was a very interactive program that was much better than listening to a lecture.

The other thing I have to report on is my movie project. I've been working a lot with Bryan on the script, and I think that the idea is coming along nicely. We decided on a working title "Life is a Train", but that may change. It's going to begin with a shot of the main character sitting on train tracks contemplating

suicide. Then it will go into flashbacks of what led him to the point of depression that he got to. There will be various things in his life that go wrong, but his best friend (a stereotypical popular kid) helps him through all of it. As it goes back to the scene of the main character on the train tracks, he decides he owes it to his friend to say goodbye at least once more. As he gets to his friends house, his friend is attempting suicide (we're not really sure how we're going to portray that without being to graphic, but it's in the process). He realizes that his friend has had lots of problems and he hasn't been there enough to support him. Then it has a happy ending and they work through their problems together.

Currently I'm working quite a bit on the logistics such as funding, travel arrangements, lodging, and a contract. I think that I'll have more time after the conference is over and then will really start making some progress.

Emily Sexton: Corey and I have been really busy with suicide prevention efforts. We presented to over 1,000 people at the elders and youth conference in Anchorage. We have attended an Applied Suicide Intervention Skills Training, or ASIST, last month. We have also been talking to the Kognito Program to create an online program for high school students. I have written a resolution on supporting the funding of this high school appropriate training to be discussed when we begin debating resolutions. We have also defined the relationship between Hope4Alaska and AASG. The board officially decided that Hope4Alaska will be the suicide prevention committee under the Alaska Association of Student Governments. Nothing will change, we just want to be clear that Hope4Alaska is a committee of the executive board and must follow AASG rules and protocol. We are still allowing non-executive board members to help in our Suicide Prevention efforts. We think this is a responsible decision because AASG handles all of our financing and we want our efforts to have the security of a larger parent organization. Corey and I also developed a grant program for Hope4Alaska. We have \$14,000 we would like to be used to make suicide prevention trainings a more accessible tool for student leaders. Our grants would defray the costs involved with attending trainings and bringing trainers to schools. If you are interested in applying for a grant to attend or bring a training to your school, talk to Corey at I at any time during the conference. Alaska Community Foundation Grants

The ACF has developed a program that will award @2,000-\$5,000 to schools to help them create a suicide prevention activity or program. The applications are online at ACF Alaska

and are due mid November. We think this is a terrific opportunity to start something life-changing and huge in your community.

SafeTalk Participants

Safetalk this year was provided through the Alaska Native Tribal Health Consortium and Barb Franks. For those who are new to AASG, Barb Franks has been AASGs biggest cheerleader in our fight against suicide. Please join me in congradulating all of the safetalk participants for challenging themselves at this conference.

Media Contest

Our media contest will continue again this year. The media contest is looking :30 second videos that promote healthy life choices. This year, ANTHC will give every submission a prize along with the three grand prize winners. Last year, commercials from Barrow High School and Port Heiden were aired hundreds of times through the kind support of GCI. The media contest also ends prior to the tri-valley. Any eboard member would be willing to help you with any questions you have, and your advisor received the flyer for the contest at registration. Presentations for other Organizations

As you heard earlier, Corey and I presented at the 2012 Elders & Youth Conference in Anchorage. We put on a two-hour workshop to over 100 people and presented to their general assembly of over 1000 delegates. Our main goal for that conference was to not get everyone there in a suicide prevention training or to start a campaign, but to begin the conversation in their communities. Many elders at the conference held the belief that talking about suicide "plants the seed" and begins suicidal thoughts, but we encouraged them to start the conversation. You may have seen us on local ABC & NBC radio stations, or heard about us on National Native News on National Public Radio.

Workshops at the Conference

The statewide suicide prevention council will be attending our conference, so hopefully many of you signed up for their educational and motivational workshop. Barb Franks has recently been re-elected to her position on the board, so at this time, we'd like to give her a round of applause for not only working her hardest to support our organization, but the statewide suicide prevention council as well.

Statewide Suicide Prevention Training

After senate bill 137 was passed while we were at the conference in Kodiak, regulations were developed to ensure that all staffs in highs schools in Alaska receive yearly mandatory suicide prevention council. Schools across the state have taken part in suicide prevention trainings on different development days throughout the year.

Grants Awareded to AASG

ANTHC continues to support our efforts by providing a speaker on suicide prevention for our spring conference in Tri-Valley.

ASAA has also supported us by giving us \$6,000 to get Judson Laipply to our fall conference.

Alaska Association of Student Governments Resolution # 1 (PASSED) Sleeve Policy Submitted by Tasha Boyer and Chugiak High School

Be it resolved by the Alaska Association of Student Governments;

- **1.** Whereas, there is a new school-wide rule that states students are not allowed to wear strapless or spaghetti strap dresses to dances (ie: prom, homecoming, etc.);
- **2. Whereas,** the new rule was imposed after many students had already purchased their dresses for prom and other upcoming dances;
- **3.** Whereas, strapless and spaghetti strap dresses often are more common than those with sleeves;

- **4.** Whereas, with the new rule students wearing such dresses would not be allowed entry at any dances;
- 5. Whereas, dance tickets are non-refundable;
- 6. Whereas, the average amount spent on a prom dress is \$195; 1
- **7.** Whereas, students rejected to dances because they violated the sleeve policy would not only lose money for the ticket, but the dress as well;
- **8.** Whereas, students can wear dresses with straps as small as the width of two fingers;
- **9. Whereas,** such dresses are hardly less revealing than strapless or spaghetti strap dresses;
- **10.** Whereas, strapless and spaghetti strap dresses still protect modesty as long as they don't violate other dress code rules;
- 11. Whereas, strapless and spaghetti strap dresses can still cover up cleavage;
- **12. Whereas,** we are not trying to change any other rules about dresses such as length, we only want to change the sleeve rule;
- **13. Whereas,** students who wish to wear more modest dresses will still have the choice to:
- **14. Whereas,** students should have the ability to express their individuality without dress sleeve restrictions;
- 15. Therefore be it resolved by the Alaska Association of Student Governments that the Chugiak High School dance policy be revised to allow strapless and spaghetti strap dresses at dances as long as they abide to the rest of the dance dress code.

Be it resolved by the Alaska Association of Student Governments;

- **1.** Whereas, students do not know what ingredients are used to prepare the food provided by the Anchorage School District;
- 2. Whereas, the condition of the food does not look healthy;
- **3.** Whereas, some students do not eat lunch because they do not know what ingredients are in the school lunches;
- **4. Whereas,** eating lunch regularly has many health benefits, such as stabilizing blood sugar levels; ¹
- **5.** Whereas, seeing nutritional information encourages healthy choices which lead to a healthier lifestyle; ²
- **6.** Whereas, eating a healthy meal leads to more participation and better grades in classes; ³

Alaska Association of Student Governments Resolution # 3 (PASSED) More Crosswalks in Thorne Bay Submitted by Thorne Bay High School

Be it resolved by the Alaska Association of Student Governments;

- 1. Whereas, there are no crosswalks in the city of Thorne Bay;
- **2.** Whereas, crosswalks allow pedestrians to be more visible to oncoming traffic;
- **3.** Whereas, crosswalks slow traffic along roadways making drivers more aware of pedestrians and speed limits;
- **4. Whereas,** installing a crosswalk would teach children how to use crosswalks for future use in more highly trafficked areas;
- **5.** Whereas, pedestrians account for 12% of all traffic fatalities;
- **6. Whereas,** over three-quarters (78%) of all pedestrian fatalities occur at non-intersections;
- 7. Whereas, over half (54%) of these are on roads without crosswalks;
- **8.** Whereas, of the pedestrian fatalities at intersections, over 40% are at intersections with no marked crosswalk;
- **9. Whereas,** about 30% of all pedestrian fatalities are related to improper crossing of the roadway or intersection;
- **10. Whereas,** in a larger city, pedestrians will be fined for jay walking, the students need to know how to use them;
- **11. Whereas,** crosswalks make walking to school a more reasonable solution;

- **12. Whereas,** by having cross walks, parents are more prone to letting their kids walk to school;
- **13. Whereas,** in 2003, almost one-fourth of all traffic fatalities for children between 5 and 9 years old were pedestrians;
- **14.** Whereas, about 20% of the students that walk to Thorne Bay school are under the age of nine;
- 15. Therefore be it resolved by the Alaska Association of Student Governments that crosswalks be establishes in Thorne Bay.

Be it resolved by the Alaska Association of Student Governments;

- 1. Whereas, the health and well-being of students is a primary concern of student governments, the Alaska School Board, and the Alaska State Legislature;
- 2. Whereas, monocrops require the use of pesticides; ¹
- **3.** Whereas, pesticides have cause several health problems in humans and non-target organisms; ²
- **4. Whereas,** children are especially susceptible to health risks from pesticides including but not limited to "blocking the absorption of important food nutrients necessary for normal healthy growth." And if a child's excretory system has not been fully developed, "the body may not fully remove pesticide." There are also "critical periods" in human development when exposure to a toxin can permanently alter the way an individual's biological system operates"; ³
- **5. Whereas,** pesticides are a suspected cause of colony collapse disorder found in bees worldwide; ⁴
- **6.** Whereas, 1/3 of all food is pollinated by bees; ⁵
- 7. Whereas, the runoff from nitrogen in fertilizer used on wide scale monocrops create agal blooms and deadzones that have been increased from 4 in 1910 to 400 in 2008; 6
- 8. Whereas, organic food does not have synthetic pesticides or fertilizers; ^{1,7}
- **9.** Whereas, there are fewer diseases crop pests in Alaska, thus farmers use fewer chemicals; ⁸

- **10. Whereas,** buying locally boosts local economy; ⁹
- 11. Whereas, agriculture is Alaska's sixth ranked industry; 8
- **12. Whereas,** Alaska produces a huge amount of seafood each year, in 2009, more than 52 percent of domestic harvested poundage in the US came from Alaska 4.35 billion pounds of product worth \$1.6 billion; ¹⁰
- **13. Whereas,** Alaska led all states in volume and ex-vessel value of commercial fishing in 2009; ¹⁰
- **14. Whereas,** "In 2011, 79% of Alaska salmon was exported to China, Japan, and Europe," food that could be used to feed our students instead;
- **15. Whereas,** if food imports were cut off, Alaskans would have only 3-5 days worth of groceries in store before everything was gone; ¹¹
- **16. Whereas,** in 2007 Alaskans spent 2.6 billion on food, of which only 1.3% was spent on agricultural products from Alaska; ¹¹
- **17. Whereas,** retrieving local food will use less gas and reduce greenhouse gas emissions; ⁸
- **18. Whereas,** state legislature allocated three million dollars to reimburse schools that buy local foods;
- 19. Therefore be it resolved by the Alaska Association of Student Governments, that AASG respectfully requests that the bill CSHCR 24 regarding local foods be continued and expanded in the upcoming 2012-2013 legislative session, and that each school should utilize it and grants similar to it to their full extents.
