

## Alaska Association of Student Governments Resolution # 3 Change to Credit Requirements for the Mat-Su School District Submitted by: Palmer High School 10/27/22

## Be it Resolved by the Alaska Association of Student Governments that:

- 1. Whereas, the Mat-su School District requires 25.5 credits to graduate from high school;
- 2. Whereas, a student in the Mat-Su School District takes six classes per year, with every semester providing a half credit for each passed class;
- **3.** Whereas, students are also required to take a seventh class for eight semesters, each semester providing .125 credits;
- 4. Whereas, a student cannot graduate from high school unless they take at least one online class;
- 5. Whereas, online classes increase stress levels of students, leading to a lower likelihood of graduating;
- 6. Whereas, students that fail a class do not have the opportunity to retake the class, except in a credit recovery class;
- 7. Whereas, credit recovery classes do not adequately teach students within the time frame of a quarter;
- 8. Whereas, credit Recovery is a Pass/Fail that will not boost a student's GPA;
- **9.** Whereas, retaking the original failed class will give the opportunity for a higher grade as well as a better learning experience;

- **10. Whereas,** students are also required to take at least one AP or IB class before graduating high school;
- **11. Whereas,** AP/IB classes require a more rigorous course load, and therefore have a higher rate of failure;
- **12. Whereas,** adding more credits to graduate can only lower the graduation rate rather than create a more thorough high school experience;
- Whereas, the state of Alaska only requires 21 credits to attain a high school diploma;
- **14. Whereas,** Fairbanks North Star Borough School district requires 22.5 credits to attain a high school diploma;
- **15. Whereas,** the Anchorage school district requires 22.5 credits to attain a high school diploma;
- **16. Whereas**, the Lower Kuskokwim school district requires 22 credits to attain a high school diploma;

**Therefore, be it resolved that the Alaska Association of Student Governments** supports changing the credit requirements needed to graduate from high school in the Mat-Su school district to 22.5 and no AP, IB, or Online Classes will be required.

Action Statement: If passed, by the General Assembly of AASG, this resolution will be brought before the Mat-Su Borough School Board for their consideration.
