

Alaska Association of Student Government Resolution #5

Support for Maintaining Middle and High School Sports in Alaska Submitted by: Frontier Charter School, Ian Utic, and Legacy Walker Submitted: 04/24/2025

Be it Resolved by the Alaska Association of Student Governments that:

- 1. **Whereas**, numerous school districts in Alaska, including the Anchorage School District and Juneau School District, have proposed or already implemented cuts to middle school and high school sports programs due to budget shortfalls;
- 2. **Whereas**, these cuts have negatively impacted students' physical well-being, extracurricular engagement, and opportunities for scholarships and future sports careers;⁴
- 3. **Whereas**, programs like middle and high school sports provide students with valuable life skills such as teamwork, leadership, and discipline;¹
- 4. **Whereas**, it is important for communities to maintain access to extracurricular activities, which help students stay engaged in their education and contribute positively to their communities;⁵
- 5. **Whereas**, other school districts, such as Kodiak Island have explored alternatives to cutting these programs, ensuring that students continue to benefit from extracurricular opportunities;^{6,7}
- 6. **Whereas**, preserving sports programs would require increased state funding or the exploration of local fundraising and partnerships with businesses to offset costs;¹

7. **Whereas**, eliminating sports programs in struggling districts would likely exacerbate mental and physical health challenges among students, furthering the effects of existing budget cuts;²

Therefore, be it resolved by the Alaska Association of Student Governments that AASG supports efforts to maintain middle and high school sports programs across all school districts in Alaska, advocating for increased state and local funding for these vital programs.

Action Statement:

If passed by the general assembly of AASG, this resolution will be forwarded to the Alaska State Legislature, the Alaska Department of Education, and local school boards to urge them to prioritize funding for middle and high school sports programs.
